## VIII Overview of the Resource Kit

#### **INTRODUCTION**

December 2012 is National Drunk and Drugged Driving Prevention Month.

The challenges we as a Nation face as a result of impaired driving were described by President Barack Obama in his 2011 proclamation:

"Although we have made progress in the fight to reduce drunk driving, our Nation continues to suffer an unacceptable loss of life from traffic accidents that involve drugs, alcohol, and distracted driving. To bring an end to these heartbreaking outcomes, we must take action by promoting rigorous enforcement measures and effective substance abuse prevention programs. During National Impaired Driving Prevention Month, we recommit to preventing tragedy before it strikes by ensuring our family members and friends stay safe, sober and drug-free on the road."

This Resource Kit is provided through an important partnership between the National SAVIN Training and Technical Assistance Project (an initiative supported by the Bureau of Justice Assistance within the Office of Justice Programs, U.S. Department of Justice) and Mothers Against Drunk Driving (MADD). It is being made available to SAVIN programs and MADD state organizations and chapters nationwide to encourage collaborative efforts to promote SAVIN programs and services, and victim/survivor and public awareness activities that can prevent impaired driving and support victims of drunk and drugged driving crashes.

 The mission of the National SAVIN Training and Technical Assistance Project is to serve crime victims and survivors, and enhance public safety by establishing standards and guidelines for comprehensive automated information and notification services. The Project provides training and technical assistance for both programmatic and technology needs, and develops resources designed to meet the diverse needs of SAVIN programs nationwide. The SAVIN Online Community (*www.savinonline.org*) features many resources about SAVIN programs, policies and technology that enhance victims' rights to information and notification.

 MADD was founded in 1980, and has grown from a small grass-roots organization into one of the most respected and effective nonprofit organizations in the Nation. The mission of MADD is "to stop drunk driving, support the victims of this violent crime and prevent underage drinking."

The MADD website (*www.madd.org*) features myriad resources and information for victims and survivors, victim advocates, justice professionals and community members to combat impaired driving, and provide support and services to its victims.

Using the contents of this Resource Kit, SAVIN and MADD programs can coordinate efforts to:

- Highlight the importance of automated information and notification services for victims and survivors of drunk and drugged driving crashes.
- Publicize the value of victim notification as a "threshold right" for victims that leads to the implementation of other victims' rights, such as protection and safety, participation, input and restitution.
- Reach out to victims and survivors through traditional and social media venues.
- Co-sponsor public and community awareness events and activities in December that promote SAVIN and MADD programs and services.

The contents of this Resource Kit are generic, to be easily adapted to whatever a state's SAVIN program is called. Any time you see "SAVIN," please substitute the name of your state's program (if it is not "SAVIN"). Throughout this Resource Kit, any text that is featured in a BLUE FONT requires personalization to your state's SAVIN program, MADD offices and chapters.

All files provided are PDFs with fillable fields for customization. Using Acrobat, an end user can click on the field, add text and save the file as a new, custom PDF. #### PUBLIC AWARENESS AND VICTIM/ SURVIVOR OUTREACH

There are four resources included in this Kit to help raise awareness about drunk and drugged driving prevention and response to victims:

- 1. **Key Facts about SAVIN and MADD** can be used to inform all your outreach activities, and/or be printed as a one-page "fact sheet."
- 2. The **sample press release** includes current drunk and drugged driving statistics including important statistics specific to holidays and a brief overview of SAVIN services. It should be typed double-spaced, and delivered to the media at least 10 days prior to when you are seeking coverage.
- 3. Two sample public service announcements in a 30 second and 15 second format can be adapted for either radio or television. You should check the PSA submission requirements of broadcast stations prior to distribution.
- 4. The sample opinion/editorial column reflects the National Drunk and Drugged Driving Prevention Month theme, "TIE ONE ON for SAFETY," and encourages community members to join efforts to prevent impaired driving, support its victims, and promote access to SAVIN services. This sample column provides a foundation for SAVIN and MADD programs to write and submit an opinion/editorial column that is specific to a state or jurisdiction.

## **KEY FACTS ABOUT SAVIN FOR MADD CHAPTERS**

The Bureau of Justice Assistance (BJA) within the Office of Justice Programs, U.S. Department of Justice administers the National SAVIN Training and Technical Assistance Project in partnership with the National Criminal Justice Association (NCJA), Justice Solutions, and the IJIS Institute, and provides training and technical assistance and other resources to state agencies that administer SAVIN programs.

- Victims of crime have rights in all 50 states. One of the most important rights is the right to information and notification.
- SAVIN automatically notifies registered victims of changes to the status of their offenders.
- SAVIN is available 24 hours a day, seven days a week, 365 days a year.
- SAVIN services are free and confidential.
- Registration is quick and simple.

## VICTIM NOTIFICATION SERVICES AVAILABLE FOR VICTIMS AND SURVIVORS OF DRUNK AND DRUGGED DRIVING CRASHES

(City/State) --- December 2012 has been designated National Drunk and Drugged Driving Prevention Month to raise awareness about the consequences of driving under the influence of alcohol and other drugs. During December 2010, 2,597 people lost their lives in vehicular crashes, and 775 of those were killed in crashes involving alcohol-impaired drivers. Behind every drunk driving statistic is a person whose life was full of family and friends, love and life, joy and laughter. The holidays are particularly hard for those who have endured the devastating effect of an impaired driving crash.

In 1986, Mothers Against Drunk Driving started the "TIE ONE ON for SAFETY" campaign. It is MADD's longest running and most visible public awareness project. During the holiday season, drivers are encouraged to display a red ribbon in a visible location on their vehicles. Red ribbons and red ribbon window decals are available through local MADD affiliates and chapters. The red ribbons represent the drivers' commitment to drive safe, sober and buckled up. Concerned citizens can show their support and "TIE ONE ON for SAFETY" this holiday season.

After an impaired driving crash, information is critical to victims. In (state), (the name of your state's SAVIN program) is a free, confidential service for victims that provides information about the status of offenders, 24 hours-a-day, 365 days-a-year. Registration for SAVIN services is simple: (provide brief information about how to register for SAVIN notification by telephone/text/ email/website here).

Survivors often say that "information is power." One survivor described how automated victim information and notification programs can have a positive and profound impact on victims: "With accurate, updated information comes empowerment. When victims have the ability to access court and offender information on their own time, it affords them the chance to regain a bit of the control that was lost and lessens the sense of helplessness." ## NATIONAL DRUNK AND DRUGGED DRIVING PREVENTION MONTH DECEMBER 2012 "TIE ONE ON FOR SAFETY"

#### 30 SECONDS

Every 90 seconds, a person is injured in a drunk driving crash. Don't wait until tragedy strikes this holiday season. Show your support for MADD's "TIE ONE ON for SAFETY" campaign, and tie a red ribbon on your antenna or display a red decal in your vehicle's window as a pledge to drive safe, sober and buckled up during the holidays.

After an impaired driving crash, information is critical to victims. (The name of your state's SAVIN program) is a free, 24 hours-a-day public service that automatically informs registered victims of their alleged or convicted offender's status. If you or someone you know is a victim of an impaired driving crash, call (area code/telephone number) or visit (web URL) online for more information or to register for SAVIN services.

#### 15 SECONDS

"TIE ONE ON for SAFETY" this holiday season and display a red ribbon on your vehicle as a pledge to drive safe, sober and buckled up. If you or someone you know is a victim of a drunk or drugged driving crash, you have the right to information and notification. (The name of your state's SAVIN program) is a free, confidential service that notifies victims about their offender's status, 24-hours-a-day. ## 2012 NATIONAL DRUNK AND DRUGGED DRIVING PREVENTION MONTH "TIE ONE ON FOR SAFETY"

The holidays are a wonderful time of year, filled with celebrations and precious time with loved ones. But for the 775 families whose loved ones were killed during December 2010 in alcohol impaired-driving crashes, the joyous celebrations ended in disaster. The holidays are difficult for families who have endured the devastating effects of an impaired driving crash. As expressed by Jan Withers, National President of Mothers Against Drunk Driving: "For those of us whose loved ones have been killed by impaired drivers, it can be especially painful to face the holidays knowing that there is an empty place in our families and hearts."

Victims of impaired driving crashes are not hurt accidentally. They are victims of a crime that is the result of two choices made by a driver—to use alcohol or other drugs incorrectly or in excess, and to operate a vehicle while under the influence of these substances. These choices are as dangerous to the public as using a deadly weapon. Thanks to the work of MADD, public awareness of impaired driving as a preventable crime has grown. MADD has over 225 affiliates and chapters nationwide with victim advocates who provide services and support to survivors, and promote awareness about drunk and drugged driving prevention and response.

In 1986, MADD started the "TIE ONE ON for SAFETY" campaign. It is MADD's longest running and most visible public awareness project. During the holiday season, drivers are encouraged to display a red ribbon in a visible location on their vehicles. Red ribbons and red ribbon window decals are available through local MADD affiliates. The red ribbons represent the drivers' commitment to drive safe, sober and buckled up, reminding others to do the same.

Victim notification and information are critical components of helping victims and survivors of impaired driving crashes to understand and navigate justice processes that may be confusing and overwhelming. (The name of your state's SAVIN program) allows victims to actively participate in the criminal justice system by registering to be notified of the status of their offender. Services are free, confidential and available 24 hours-a-day, seven days-a-week, 365 days-a-year. ## Drunk and Drugged Driving Statistics

 Some of the deadliest days of the year for drunk driving are around the holidays. This chart describes the percentage of traffic fatalities during holidays – over a three-year period – that involved drunk driving:

Holiday	2008	2009	2010
New Year's Holiday	175 (41%)	185 (40%)	143 (48%)
New Year's Day	54 (51%)	68 (60%)	78 (57%)
Thanksgiving	180 (35%)	140 (34%)	174 (40%)
Thanksgiving to New Year's	1,050 (29%)	895 (29%)	976 (31%)
Christmas	138 (32%)	95 (36%)	96 (37%)
New Year's Eve	28 (30%)	23 (27%)	35 (37%)

- In the United States, the number of drunk driving deaths has been cut in half since MADD was founded in 1980. (National Highway Traffic Safety Administration FARS data, 2011.)
- Every day in America, another 28 people die as a result of drunk driving crashes. (National Highway Traffic Safety Administration FARS data, 2011.)
- Almost every 90 seconds, a person is injured in a drunk driving crash. (Blincoe, Lawrence, et al. "The Economic Impact of Motor Vehicle Crashes 2000." Washington, DC: National Highway Traffic Safety Administration, 2002. NHTSA FARS data, 2011.)
- In 2010, 10,228 people died in drunk driving crashes

   one every 52 minutes and 345,000 were injured in drunk driving crashes. (National Highway Traffic Safety Administration FARS data, 2011.)
- Drunk driving costs the United States \$132 billion a year. (National Highway Traffic Safety Administration FARS data, 2010.)
- On average, one in three people will be involved in a drunk driving crash in their lifetime. (National Highway Traffic Safety Administration. "The Traffic Stop and You: Improving Communications between Citizens and Law Enforcement." March 2001, DOT HS 809 212.)

- An average drunk driver has driven drunk 80 times before first arrest. (Centers for Disease Control. "Vital Signs: Alcohol-Impaired Driving Among Adults — United States, 2010." Morbidity and Mortality Weekly Report. October 4, 2011.)
- Since 1980, MADD has nearly saved 300,000 lives...

- Motor vehicle crashes are the leading cause of death among teens aged 16–19 years old in the United States. (Centers for Disease Control. Web-based Injury Statistics Query and Reporting System [WISQARS]. US Department of Health and Human Services, CDC; 2011.)
- The number of teenagers who are drinking and driving has dropped by 54% in the past two decades. (Centers for Disease Control. "Vital Signs: Drinking and Driving Among High School Students Aged ≥16 Years — United States, 1991–2011". Morbidity and Mortality Weekly Report. October 2, 2012.)
- In 2010, 697 (20%) of the 3,405 drivers aged 16–19 years old involved in fatal crashes (defined as a crash in which at least one person involved in the crash died within 30 days) had positive BACs. Among those 697 teen drivers, 568 (81%) had BACs ≥0.08%, the level designated as illegal for adult drivers. (Centers for Disease Control.
