OVS is committed to assisting victims and survivors throughout the duration of their offender’s incarceration and supervision. We are dedicated to ensuring that crime victims are treated with dignity and respect.

A victim’s need for assistance does not stop once an offender has been sentenced. In fact, it continues throughout an offender’s custody and OVS is the arm of Corrections that handles those requests for assistance.

Services Offered by OVS

- Information and referrals
- Information about the status of an offender
- Referral for victim restitution inquiries
- Assistance with the Kentucky VINE, VINE Court and VINE Protective Order services
- Notification of upcoming parole hearings
- Processing of requests for notification upon release
- Training for criminal justice and other victim service professionals on awareness and sensitivity issues, as well as the VINE system
- Visits to county jails and victim service providers along with criminal justice professionals to distribute promotional materials related to victim services offered by the Department

Victim Input into Parole Board Decisions

The Kentucky Parole Board notifies victims of Class A, B, or C felonies of pending parole hearings 45 to 90 days prior to the offender’s hearing. Victims may request upcoming parole information by calling the Victim Services Division of the Parole Board at 800-221-5991. Victims should notify the Parole Board of address changes after the court proceedings.

Notifications include the offender’s name, parole eligibility date, and a victim impact statement (VIS). Victims are encouraged to complete the VIS and promptly return it to the following address: Kentucky Parole Board, Attention: Victim Coordinator, P.O. Box 2400, Frankfort, KY 40602-2400.

The law requires that anyone who wishes to meet with the Parole Board for a victim hearing advise the Board in writing, no less than seven days prior to the offender’s hearing.

In an effort to ensure that all interested individuals are notified, the Department of Corrections offers parole eligibility notification through VINE. The automated notification service is provided to anyone who registers with VINE, but is not intended to replace the required written notifications.

Written Notification of Offender Release

If a victim as defined by KRS 421.500 wishes to be notified of an offender’s release from a Department of Corrections facility as required by KRS 197.170, a request should be made in writing and should include the victim’s name, current mailing address and phone number, along with the offender’s name and institutional number if known.

Offender Status

VINE is a free, anonymous, computer-based service that provides the public two important services: information and notification.

VINE will tell you if an offender is in jail or prison and will give you other important custody information. VINE will also let you provide a phone number and/or an e-mail address where you can be notified automatically when that offender is released, transferred, escapes or has an upcoming parole hearing.

Registering with VINE

Call 800-511-1670 from a touch-tone phone. If the offender is in custody, you can register to be notified when the offender is released. Enter the phone number or numbers where you want to be reached, including area code, followed by the pound (#) key.

When VINE asks, enter a four-digit Personal Identification Number (PIN) that you choose. Write it on the back of this brochure or in a safe place. When VINE sends a notification, you will be asked to enter the PIN. This will confirm that you received the call and stop additional calls.

To register for e-mail notification, go to www.vinelink.com and click on the state of Kentucky. You can search for the offender by name or identification number. Once you locate the offender, you can enter an e-mail address or phone number where you would like to be notified if the offender is released, transferred or escapes.

Do not depend solely on VINE for your protection. If you feel that you may be at risk, take precautions as if the offender has already been released.

Court Hearings

VINE Courts® will allow you to search for information on a specific felony or misdemeanor court case. You can also register a phone number or e-mail address where you want to be notified when there is an upcoming court hearing or a scheduling change in an upcoming court hearing.

*Please note that it is the responsibility of the registrant to keep up with his or her case number, including trailer number if applicable, and to keep the registration current.

Registering with VINE Courts

Call 800-511-1670 toll-free from a touch-tone phone and follow the instructions. You can also register online at www.vinelink.com for offender custody status changes or www.courts.ky.gov and click on “VINE Court Services” to register for a court case. (To register your e-mail address, either visit one of the Web sites mentioned above or press 0 to speak with an operator.)

When searching for a court case, you can register your phone number to receive updates on court hearings. Enter the phone number where you want to be reached, including area code, followed by the (#) key.

When VINE asks, make up a four-digit personal identification number (PIN) that will be easy for you to remember. VINE will ask for the PIN when it calls you.

When VINE calls, listen to the message then enter your PIN when asked. This will confirm that you received the call and stop additional calls.

Protective Orders

VINE Protective Order® (VPO) is a free telephone service that allows petitioners to access information about their protective orders, including the status of the order and reminders about upcoming court hearings. You can also receive information regarding terms and conditions of the order, if the respondent has been served with, or received the order, information about the next court hearing, as well as the expiration date of the order.

Before you call VINE Protective Order, have your case number ready. You can find it on your petition (application form) or protective order (Example: case number 07D123456-001).

Registering with VINE Protective Order

Call 800-511-1670 from a touch-tone phone and press two (2) for protective order information. When asked, enter a telephone number where you can be directly reached and a four-digit personal identification number (PIN) that you choose. You may write these four numbers on the back of this brochure, but keep them protected.

When you receive a telephone notification, you will be asked to enter your PIN, followed by the pound (#) sign, to hear the notification and to confirm that you received the call.

If you have registered but have not heard that the order has been served after four days, contact your victim advocate or county sheriff’s office. More information about how to find the respondent may be needed.

To check the status of a protective order:

Call the toll-free Kentucky VINE Line at 800-511-1670 from a touch-tone telephone. To search for the status of a protective order, press two (2) for protective order information. Enter the case number followed by the pound (#) sign. Use the numbers and letters on your keypad. If you do not have a touch-tone phone, simply wait on the line until you are connected to an operator.

FACTS

- You must register separately for each VINE service: Offender Status, Court Hearings, and Protective Order
- Operators are available 24 hours a day
- It is important to remember and protect your PIN
- For safety reasons, you should never share your PIN number with anyone
- The offender will not know you are registered with any of the VINE services. ALL VINE SERVICES ARE ANONYMOUS
- If you do not answer, VINE will leave a message. If there is no answer, VINE will keep calling back until you enter your personal identification number (PIN) or until up to 48 hours have passed
- Do not register a phone number with VINE that rings to a switchboard
- You can register multiple phone numbers and e-mail addresses with VINE
- Do not depend only on the VINE service or any other single program for your protection. Make these services a part of your safety plan
- To register to receive court notifications, you must have the complete case number, including trailer number if applicable
- Since VINE calls automatically when an offender’s custody status or the status of a protective order changes, you may get a notification call in the middle of the night. Court notification calls will only be made between 9 a.m. and 8 p.m.
- If a telephone number or e-mail address you have registered with VINE is changed or is no longer being used, please contact VINE to provide your updated contact information
